

TOWNSHIP OF DRUMORE

RESOLUTION NO. 2014-05

The Board of Supervisors of the Township has this 1st day of May 2014 adopted Ordinance No. 2014-01 which is a new comprehensive Drumore Township Stormwater Management Ordinance (“**SWMO**”) for the Township.

The SWMO specifically allows the Board of Supervisors from time to time, by Resolution, to establish certain fees and deposits for the purposes of administering and implementing the terms and conditions of said SWMO.

The Board of Supervisors has determined that the following fee and deposit schedules are in the best interest of the Township and should be adopted as the Fee and Deposit Schedule for the new SWMO.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the Township of Drumore and it is hereby Resolved by the authority of the same, that the following filing fee schedule and deposit schedule shall be in effect in the Township for Stormwater Management Plans (“**SWMPs**”) under the SWMO until changed by further Resolution of the Board of Supervisors:

FILING FEE SCHEDULE

A. For Stormwater Management Plans, pursuant to Section 504 of the SWMO, a fee of **\$300.00** for each Application.

B. For each request from a waiver/modification of the provisions of the Ordinance, a fee of **\$50.00** for each waiver.

C. For Small Project Applications, pursuant to Section 502 of the SWMO, a fee of **\$150.00** for each application.

D. For Exemption Applications, pursuant to Section 501 of the SWMO, a fee of **\$0.00**.

DEPOSIT SCHEDULE

A. For SWMPs Applications, pursuant to Section 504 of the SWMO, a fee of **\$1000.00** for each Application.

B. For Small Projects, pursuant to Section 502 of the SWMO, a deposit of **\$500.00*** for each Application. (*Fee \$750.00 effective 01-01-2020)

C. For each Exemption Application, pursuant to Section 501 of the SWMO, a fee of **\$75.00****. (**Fee \$100.00 effective 01-01-2020)

D. If, in the opinion of the Township Designee, the deposits filed by any applicant have been reduced to a point that in good faith it is not deemed probable that the reviews can be accomplished by Township Officials within the budget of said deposits, the Township Designee shall require a submission of additional deposits, from time to time, so to adequately secure the payment of all Township costs and expenses, in review of and associated with, all subdivision and land development plans.
